- 4. Treasurer's Report Presented by treasurer Michelle Service. Opening balance of \$29,357.42, expenses were \$559.66 (for Hot Lunch), income of \$1.11 (credit Interest). Balance of \$28,798.87 for Feb. 28/19. Michelle S. moved that the report be adopted as presented. Robyn M. seconded. Robyn M. motioned that it be recognized that Dawn Service informally audits R.E.S. Council books from last year. Matilda K. seconded.

- 6. New Business
 - 6.1 Inclement Weather Decisions Message from Jayson Lovell. All in attendance watched the Presentation from Jayson Lovell, which discussed the AP 132: Closure of Schools Due to Inclement Weather. The AP 132 guides decisions for school closure, due to inclement weather. With safety of students as the primary concern, the Superintendent and Transportation Manager make a joint decision, between 5:30 a.m. and 6:00 a.m., on school closure and cancelling buses. AP 132 has been followed for decades, and is applied consistently using Environment Canada conditions, and a network of contacts. Buses are

cancelled and schools are closed when ambient air temperature is -40°C, air temperature between -30°C and -40°C AND wind-chill factors in excess of -40°C, dangerous road conditions and/or poor visibility, and buses may be cancelled, and schools remain open if conditions (such as fog or freezing rain) are expected to improve. Schools are closed when buses are cancelled because WCPS also believe conditions are not safe for students to be traveling to school. Closing schools through extreme weather conditions ensures WCPS' is doing everything possible to keep students safe. It is not feasible to close one school and leave others in the same community open, as weather impacts a region, and families could have students in more than one school. Safety must remain a priority.

- As a group, we completed a survey for feedback through a Google Form.
- 6.2 School Crosswalk –Our council in conjunction with RJSH council and Wolf Creek's senior administration team sent a letter to the Town of Rimbey about the need to install crosswalk lights at 52nd Street and 52nd Avenue. These lights are to enhance the safety of students and pedestrians as it is such a busy street and visibility can be poor. The Town is under the impression that Wolf Creek is responsible, but it was voiced that IS the Towns responsibility. Unfortunately, our letter did not get brought up at the last town council meeting. Jodi had said Jacey might go and voice our needs to the Town in person.
