## **Respiratory Illness Outbreak Information**

• Absences steadily increasing since Sept. 7

## Absentee Rates

- Sept. 10: 17% students absent/11% Reporting Symptoms (9 active cases)
- Sept. 13: 28% students absent/ 17% Reporting Symptoms
- Sept. 14: 25% students absent/18% Reporting Symptoms
- School has had 11 positive cases to date
- Required to contact AHS upon absentee rate of 10% or greater OR clusters of common symptoms
- Investigation was completed by Center for Disease Control (CDC): they contacted some families to determine if it is a respiratory illness within the school.
- CDC Declaring RE an Outbreak School (Bluffton also Outbreak and RJSH is experiencing a high number of absences).

## Next Steps:

- AHS & Health Inspector investigated our current measures and assist in dealing with Outbreak Best Practices to limiting the spread:
  - Strongly recommend masking
  - Frequent cleaning of high touch surfaces

- Sanitizing & Handwashing
- Cohorting/Limiting Movement: multiple students in hallways at same time/Limit mixing of Cohorts
- Staggering entrances & exits
- Daily Health Checks: symptom free or stay home

Maria Tisdale joined the meeting.

#### 7.2 Outdoor Rink

Kathleen Hull-Beagle reported on the progress of the outdoor rink at the school.

- \$22,000.00 has been raised to date
- a cement base will add to the cost
- Hawktail Breweries has raised \$5- \$6,000
- The Co-Op has donated \$1500.0
- There was a discussion regarding the Legacy Tree Project and the money that has been raised/donated to date.

MOTION: By Kelly Fowler (LeBlanc) that the funds raised for the Outdoor rink be kept in the Foundation account and accounting for it be kept separate and reported that way. Seconded by Michelle Service. CARRIED.

#### 7.3 School Trustee's Report

 No formal Board meetings have been held but two Special meetings have been. The first was to discuss the Calendar with respect to September 30th being Orange Shirt day in conjunction with the Truth and Reconciliation Federal Holiday. Wolf Creek will observe that day. The second meeting was to determine whether or not masks will be worn in the schools and the decision was not to mandate masks. The new boundaries for the upcoming election are in place. We are holding most of our meetings via Zoom and are meeting more frequently now that school has started.
